Entry fees: **\$24.00** one entry of dog each day
(including \$3/run AKC recording fees) **\$36.00** for both Standard & JWW each day
There will be a \$25.00 service charge for any returned checks.

All express mail must be left with no acceptance signature required. NO FAX OR ONLINE ENTRIES. Envelopes with more than 10 dogs' entries will be returned. Checks returned for insufficient fees will invalidate the entry; acceptance of such an entry will only be made if the full fees, plus a \$25 administrative fee, are paid via certified check, money order, or cash, & received prior to the start of judging.

Entry forms with email addresses will be sent entry receipts, as well as final confirmations, via email. CAPER is not responsible for non-delivery of emails due to delivery errors or spam blockers, and no further efforts will be made. Entries without email addresses will receive only final confirmations after closing. If receipt of entry notification is desired, a self-addressed, stamped postcard or envelope must be included with the entry forms.

SITE INFORMATION: The trial rings will be outside on a flat grassy area and will be 110' x 100' in size. Shade is minimal, and tents are allowed. No tents within 20 feet of the rings. SCVKC will not be responsible for any lost or damaged items left at the trial site. The site will be available to exhibitors at 8am Wed, August 25. Please pick up after your dogs and yourselves. **Anyone witnessed not picking up after his/her dog will be excused from the trial with no monies refunded.**

RV PARKING: Overnight RV parking is available in the agility area for \$15/night. No hookups or electricity. No overnight tent camping is allowed. Please complete the reservation form and return it by August 15th to reserve a space. Camping with complete services is available in another part of the fairgrounds; information available in the conformation premium list at onofrio.com.

FOOD: Food service will be available in the agility area from Cookie Baker Inc.

OBSTACLES: Obstacles will meet the current specifications in the Agility Regulations. Weave poles 24" on center.

MOVE-UP REGULATIONS: If a dog earns an agility title before this event it can be advanced to the next level of competition. However, written notice must be sent to the trial secretary **no later than 6pm on Monday, August 23.** Email moveups are encouraged. Every effort will be made to accommodate handlers running multiple dogs in the same class. No verbal changes will be accepted.

MEASURING: All dogs participating in this trial must have an AKC height card or they will need to be measured prior to running in the trial. Two VMOs will be in attendance to measure for official height cards. **Copies of height cards DO NOT need to be sent with entries or shown at the trial!**

It is the owner's responsibility to have the dog measured prior to running. Awards may be cancelled if the dog is not measured before running.

See the entry form for the appropriate box to check regarding height cards. A "temporary form" is the long yellow form given when a rep or VMO measures a dog. A "permanent card" is the wallet-sized white card sent by AKC.

REFUNDS: Entry fees will not be refunded in the event of errors or cancellation of entries after the published closing date; in the event that a dog is absent, disqualified, excused by the veterinarian or judge, or barred from competition by the Trial Committee; or in the event that extreme weather conditions, riots, civil disturbances, or other acts beyond the control of the Trial Committee make it impossible to open or complete the show/trial. Refunds for bitches in season will be partially refunded, if requests are submitted to the Trial Secretary at least 30 minutes prior to the start of judging for the day and are accompanied by a veterinarian certification.
